**ORDER:-**

The Director General of Foreign Trade, Ministry of Commerce and Industry, Government of India, New Delhi in their Notification first read above has accorded permission to the State Government of Andhra Pradesh to export 8,584.1363 MTs. of Red Sanders Wood in log form out of confiscated/seized stock available with the State Government either by itself or through any entity/entities so authorized by the Government and the whole process of export shall be completed latest by 30th April, 2019.

2. In the G.O. second read above, the Government have constituted a Tender Committee under the Chairmanship of Principal Secretary to Government, EFS&T Department to work out the modalities for conducting sale of Red Sanders Wood in log form through Global e-Tender cum e-Auction.

3. The Government, after careful examination of the proposal of the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Limited received in the reference 3<sup>rd</sup> read above, hereby order on the recommendations of the Tender Committee as summarized below:-

- a. Accept the Special Terms and Conditions for conducting global e-tender-cum-e-auction proposed by the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd.
- b. Authorize the Andhra Pradesh Forest Development Corporation Limited to engage the services of M/s MSTC Ltd. for conducting the sale of Red Sanders Wood through global e-tender cum e-auction on the terms and conditions approved by the Government in ITE & C (e-procurement) Department vide G.O. Rt. No. 47, Dated.5-7-2017 or as the revised terms by the Government or at the present rate of commission payable whichever is low.
- c. Direct the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd. to issue tender notification in reputed International and National publications and specialized journals targeting the potential buyers, across the World especially in the China in the local languages as Government orders for sale of Red Sanders Wood of about 1363.53 MTs. in log form through e-tender-cum-e-auction by inviting global tenders through transparent and competitive process.

- d. Direct the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd. to circulate copies of the tender notification to the Ministry of External Affairs (MEA) and all ambassadors and foreign Missions especially that of China, Japan, Malaysia, Singapore, UAE, Thailand and Indonesia and Indian embassies in China, Japan, Malaysia, Singapore, UAE, Thailand and Indonesia etc.
- e. Authorize the Tender Committee to make any improvements in the process of sale that would maximize returns to the State.

4. The Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, / Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd., shall take further necessary action in the matter accordingly.
