# 2. Proposals on Transfer of ownership:

The SLC reviewed and deliberated upon the proposals received from the field, in detail, after segregating them into various categories and decided for each category as detailed below:

# a. Transfer of ownership by Succession

The list of (18) sawmill cases of Transfer of ownership by succession, placed before SLC, were examined by the members of the Committee and agreed to transfer the ownership under Rule 11 in (13) cases from S. no. 1 to 13, wherein both the Conservator of Forests and Divisional Forest Officers have recommended for the transfer of ownership.

For (5) cases from S.no. 14 to 18, as the Circle Head, Rajahmundry has not furnished his recommendations and remarks, the committee authorized the Prl.CCF & HoFF to take appropriate decision to accord permission for transfer of ownership after receipt of reports from the Circle Head, Rajahmundry.

#### (2) Sri Sai Sawmill & Timber Depot, Y. Palem, Prakasam District

The proposal for renewal of the license of the said saw mill, placed before SLC, has been examined by the members of the Committee and agreed to the proposal for renewal as recommended by the CF and DFO.

#### (3) Authorizing the Divisional Forest Officers (T) for renewal of licences:

The SLC resolved to authorize the Licensing Authorities/DFOs to renew the licenses of the existing Saw Mills, beyond 31 st December, 2020, under rule 10 (5).

(4) The SLC resolved to authorize the Divisional Forest Officers (T) to renew the licenses of those eligible sawmills which made late remittance of

enhanced fee as per rule 4 (3), subject to appropriate action by the Licensing Authorities under Rule 14 (2)(b).

**(5)** The committee resolved to direct the Licensing Authorities henceforth to ensure that the applicants who wish to get fresh/new license, or relocate a saw mill shall invariably obtain the certificate regarding the "Distance from the nearest forest boundary" using the online facility created by the Forest Department as part of Ease of Doing Business (EoDB) initiative of the GoAP.

The meeting concluded with the Prl.Chief Conservator of Forests & Head of Forest Force thanking all the members for participating and providing valuable inputs.
