reference 2<sup>nd</sup> cited was not finalized and not decided anything about its cancellation or otherwise. Thus two types of Provisional Seniority Lists are against the Provisions in A.P. State and Subordinate Service Rules and Non est. in Law.

Hence, the objections raised do not deserve any consideration.

Similarly the Provisional Seniority Lists of ACFs as on 01.01.2016 was also communicated in PCCF & HoFF, A.P., Hyd. Rc.no.408/2016/Admn.2(ii), dated 19.04.2016 without even approval of the competent authority i.e. Government. Based on such illegal Provisional Seniority Lists, Dy.CF Promotions were also affected which caused lot of injustice to the Promotee ACFs. However, another Provisional Seniority Lists as on 01.01.2016 communicated in Govt. Memo no.EFS01-FRSTOFSER (AFSR)/126/2019-SEC-V, dated 09.07.2020 without mentioning the names of some of the Promotee ACFs and Ad-hoc ACFs is another painful event, illegal and it is gross violation of the in A.P. State and Subordinate Service Rules, 1996. Hence, the decision on the previously communicated Provisional Seniority Lists is pre requisite to be decided by the authority for doing the justice to the Ad-hoc ACFs.

The objections are disposed off accordingly.

Finally, the action taken by the benign authority in communication of dual (two) Provisional Seniority Lists is illegal and it is without any such Provision either in the A.P. State and Subordinate Service Rules, 1996 or in A.P. Forest Service Rules, 1997 and hence justice may be done by rectifying the same.

**(b) Provisional Seniority Lists as on appointed day i.e., 02.06.2014**

Assistant Conservator of Forests is a State cadre post and belongs to State Forest Service. Upon State bifurcation, the Government of India in consultation with the Kamala Nathan committee has already completed the allotment/ division of Assistant Conservator of Forests between the two states. The Service Rules does not provide for requirement of any seniority as on the appointed day. It is relevant to mention here, in the absence of the Provisions in the Service Rules no other department has initiated such Seniority Lists of their State Cadre



employees as on appointed day. It is also submitted that the GAD (Services) has not given any such instructions. Hence the communication of such Provisional Seniority Lists as on appointed day is illegal.

However it is painful to note that it does not contain the names of some of the Promotee ACFs and Ad-hoc ACFs available as on appointed day, similar fate might be there for some of Direct Recruit ACFs also. Hence the Provisional Seniority Lists as on appointed day is against the A.P. State and Subordinate Service Rules, 1996 and A.P. State Forest Rules, 1997, and as such it is to be treated as illegal and Non est. in law.

Hence it is requested to take further necessary action to cancel the Provisional Seniority Lists as on appointed day.

**(c) Missing of names in the Provisional Seniority Lists**

Certain Promotee ACFs whose names are reflected in the Provisional Seniority Lists of 2014, 2015, 2016 etc., and the same names found missing in Provisional Seniority Lists of subsequent years. The names of certain Promotee ACFs were included in Provisional Seniority Lists of 2014 to 2018 and certain other names of Promotee ACFs were excluded in the Provisional Seniority Lists of 2014 to 2018. The following are the some of the examples of such inclusions and exclusions:

**Example 1:**

The names of  
**1.**Sl.No.1 to 51 of Promotee ACFs and  
**2.**Sl.No.1 to 55 of Ad-hoc ACFs are shown in Provisional Seniority Lists as on 01.01.2014 communicated PCCF & HoFF, A.P., Hyd. Rc.no.6073/2014/M4, dated 30.05.2014 and the same are not reflected in the Provisional Seniority Lists as on 01.01.2014 communicated in Govt. Memo no.EFS01-FRST0FSER (AFSR)/126/2019-SEC-V, dated 09.07.2020, which was communicated now and called for objections. The reasons for such missing are not known and hence same may please be looked into.



**Example 2:**

The names of all Ad-hoc ACFs are shown in Provisional Seniority Lists as on 01.01.2014 communicated in PCCF & HoFF, A.P., Hyd. Rc.no.408/2016/Admn.2(ii), dated 19.04.2016. But they are not reflected in the Provisional Seniority Lists as on 01.01.2015 communicated in Govt. Memo no.EFS01-FRST0FSER (AFSR)/126/2019-SEC-V, dated 09.07.2020, which was communicated now and called for objections. The reasons for such missing are not known and hence same may please be looked into.

**Example 3:**

The names of 18 Ad-hoc ACF's out of 25 Ad-hoc ACF's, which are shown in Provisional Seniority Lists as on 01.01.2014 communicated in PCCF & HoFF, A.P., Hyd. Rc.no.408/2016/Admn.2(ii), dated 19.04.2016. But they are not reflected in the Provisional Seniority Lists as on 01.01.2016 communicated in Govt. Memo no.EFS01-FRST0FSER (AFSR)/126/2019-SEC-V, dated 09.07.2020, which was communicated now and called for objections. The reasons for such missing are not known and hence same may please be looked into.

**Example 4:**

The name of Sri N.V. Siva Rama Prasad (Sl.No.52) shown in the Provisional Seniority Lists as on 01.01.2016 and the same is not reflected in the Provisional Seniority Lists as on 01.01.2017 and again reflected in the Provisional Seniority Lists as on 01.01.2018. The reasons for such things not known.

Hence, as such all the Provisional Seniority Lists needs to be cancelled and to be communicated again by including the names of the eligible ACFs including full members of ACFs (DR & Promotee) and Ad-hoc ACFs in order to do equitable justice to all the ACFs.

**(d)Irrelevant/Contradictory foot note in the Provisional Seniority Lists**



As seen from the foot note of the Provisional Seniority Lists, it is observed that the details of the names mentioned in the foot note are not figured among the list of the members of ACFs in the said list. Hence as such the foot note is irrelevant to the Seniority List and the purpose of mentioning such arbitrary foot note is totally contrary to the Service Rules and contradictory to the list of ACFs mentioned in the said list. Hence the irrelevant / contradictory foot note needs to be deleted from such Provisional Seniority List.

**(e) Delay in communication of Provisional Seniority Lists**

As per the A.P. State and Subordinate Service Rules, 1996 and A.P. State Forest Rules, 1997, the Seniority Lists of ACFs has to be communicated and finalized as on 1<sup>st</sup> January of every year. This is being delayed without any reasons and it is being communicated after a lapse of 6 years with lot of infirmities as enumerated above causing injustice and frustration among the Promotee ACFs as such Justice delayed is Justice denied. It is requested to do the justice to the Promotee ACFs by avoiding delays in future.

**II. Violation of settled Principles and practices**

**(a) Violation of 1995 Waghay Judgement**

There is a well settled procedure being followed from 1995 to 2013 basing on the guidelines issued in Waghay Judgement which was upheld by Hon'ble Supreme Court for preparation and finalization of Seniority Lists of ACF's. As per the said judgement, the vacancies/ cadre strength has to be apportioned between Direct Recruittees and Promotees basing on the respective quota and the said procedure need to be explained in clear terms in the Provisional Seniority Lists. But the present Provisional Seniority Lists are devoid of such explanatory note which is gross injustice to the promote ACF's and the same may please be rectified.

**(b) Violation of Quota - Rota**

The Procedure is well settled



for application of Quota - Rota rule among Direct Recruitess and Promotees against Vacancies / Cadre strength. As per the latest amended service rules, 1/3<sup>rd</sup> of the ACF's should be Direct Recruitess and the balance 2/3<sup>rd</sup> of ACF's has to be promotees. The quota has to be explicitly mentioned in the Provisional Seniority Lists and it needs to be explained in order to do justice to all the Promotee ACF's.

**(C) Lack of Worksheet/ Introductory Note:**

The apportionment of Vacancies / Cadre strength in year wise is also being communicated to all the ACF's in the form of Worksheet / introductory as a part of the Provisional Seniority Lists for giving more clarity on Provisional Seniority Lists. This was followed up to 2014 based on the court orders and settled principles and practices. But the present Provisional Seniority Lists does not contain any such Worksheet / introductory note about the apportionment of Cadre strength / Vacancies between DR's & Promotees. Hence the confusion araised among many Promotee ACF's. Hence it is requested to rectify the anomaly and do the needful justice to all the Promotees.

**(d) Absence of List of Ad-hoc ACF's**

It is well settled principle that the list of Ad-hoc ACF's also should be kept as an Annexure below the list of full members as per the Waghayr Judgement which was upheld by the Hon'ble Supreme Court of India. It is observed that the list of Ad-hoc ACF's is found missing in all Provisional Seniority Lists from 2014 to 2018 communicated in Govt. Memo no.EFS01-FRST0FSER (AFSR)/126/2019-SEC-V, dated 09.07.2020. However such list is found placed in first Provisional Seniority Lists of 2014 & 2016. It is requested to rectify the anomaly and include the list of Ad-hoc ACFs in all the Provisional Seniority Lists communicated in Govt. Memo no.EFS01-FRST0FSER (AFSR)/126/2019-SEC-V, dated 09.07.2020.



		<p><b><u>III. Individual issues:</u></b></p> <p>The individuals were promoted as ACFs in different panel years and they are on the rolls of ACFs from 2010-11 Panel. Hence, their Seniority has to be from 2010-11 panel year based on the general Principle of continuous officiating. They have been granted the pay fixation and drawl of salary as per Fundamental Rules. Hence, their Seniority is also to be fixed Panel as per rules in force. Accordingly, their names have to be figured among the list of ACFs in all Provisional Seniority Lists communicated in Govt. Memo no.EFS01-FRST0FSER (AFSR)/126/2019-SEC-V, dated 09.07.2020. But it is painful to note that their names are figured in the Provisional Seniority Lists of 2018 only and caused gross injustice not only to the service rendered by them but also to future career and promotions. Hence it is requested to rectify the anomaly and do the needful justice.</p>

6. As on 30.07.2016, not even provisional seniority list of in ACFs was finalized for the years from 01.01.2010 to 01.01.2018, but the Screening Committee which met on 30.07.2016 has prepared the panel for Dy.CFs for the year 2015-16 "in the order of established Seniority."

7. The names of some of the ACFs, namely, M.Babita, G.Krishna Priya, V.Sai Baba, S.Venkatesh, K.Mehaboob Basha, G.A.P. Prasuna, M.Hima Sailaja, G.Rama Krishana Rao, Y.Ramesh and A.Ravi Simha Murthy were included in the panel for promotion in the category of Dy.CF for the panel year 2015-16, were not even have any mention of their names in any of the established / settled seniority list communicated.

8. In G.O.Ms.no.98, E,F,S&T (Sec.V) Dept., dt.18.12.2017, Government have issued orders by promoting (9) ACFs to Dy.CFs for the panel year 2016-17 basing on the proposals submitted by the PCCF..... as on the date of 17.08.2017 not even the provisional seniority list of ACF was finalized for the years from 01.01.2014. But, in the Government orders it is mentioned that the panel for Dy.CFs for the year 2016-17, it is stated that the eligible ACFs in the seniority list for considered, which is false. Hence, the Government orders in G.O.Ms.no.98, dt.18.12.2017 has to be set-aside until the finalization of seniority lists of DY.CFs and ACFs.

9. In "Seniority-cum-merit" the promotions are to be made on the basis of the eligibility criteria, procedure and on the basis of seniority after determining merit of the candidates falling in the "zone of consideration" i.e., three times the number of vacancies occurring. Hence, final settled seniority list is inevitable in preparation of list of ACFs falling in zone of consideration for promoting to the cadre of Dy.CFs.

10. The case law on "seniority-cum-merit" are mentioned along with the memos from the Government of India, dt.22.07.1996 and 14.03.1963. The observations of

said seniority have been followed in preparing the present provisional year-wise seniority of ACFs as on 01.01.2015 to 01.01.2018.

Further, G.O.Ms.No.25, EFS & T (Sec.V) Dept., dated 11.05.2022 has also been issued by following the same principles.

Moreover, Sri P. Maruthi Prasada Rao was promoted as ACF on 31.08.2020.

Hence, his objections to the seniority lists as well as promotions made prior to his promotion as ACF are not valid.

The objections raised do not deserve any consideration.

The objection is disposed off accordingly.
